Major Gifts

- Received a two-year, \$250,000 investment from Bank of America Charitable Foundation to name and add enhancements to the lobby of the Finger Lakes Workforce Development Center (FWD Center) at MCC's Downtown Campus. Todd Baxter '10 and Ken Hines were instrumental in helping us develop our relationship with Bank of America.
- Established the Mark Harris Memorial Scholarship with a pledge of \$108,750 from Lynn Harris. This fund will support students pursuing careers in emergency medical services at MCC's Public Safety Training Facility. Maureen Wolfe helped connect Mrs. Harris with us through her financial advisors.
- Secured a \$50,000 grant from the Lumina Foundation to assist MCC's Marketing and Web Department with updating its catalogue of videos for the College's website and social media accounts.
- The Davenport-Hatch Foundation awarded a \$45,000 grant to renovate underutilized space at the Richard M. Guon Child Care Center into private therapy rooms for children who receive early intervention services.
- The Rochester Chapter of the American Society of Heating, Refrigerating and Air-Conditioning Engineers (ASHRAE) established the Charles Lynch Memorial Scholarship with a pledge of \$10,870. This fund will support students in MCC's heating, ventilating, and air conditioning program.
