SPEAK TO SEGA

MCC Association Inc.

- Mr. Marchese presented a brief overview of the Student Association budget process.
- In order to have a balanced budget, allocations must equal projected revenue.
- The Student Association budget will be voted on by SGA and SEGA, then the MCC Association Inc. Board of Directors.

Student Trustee

- Mr. Visagie and Mr. Hollander are working on a petition that students can sign regarding budget cuts to MCC and SUNY. They plan to take the petition with signatures to Albany on March 15.
- SEGA will collect signatures next week and present to Mr. Visagie on March 11.

UNFINISHED BUSINESS

Programming Budget for 2011-12

- Mr. Carey presented the proposed programming budget for 2011-12, which reflects an increase over the current year.
- SEGA will vote on the programming budget at the next meeting.

SEGA Election Packet

- Ms. Wallace presented the proposed SEGA Election Packet, which reflects only date changes from last year's packet.
- The proposed application deadline is April 15; however, the Monroe Doctrine's deadline for accepting articles/photos of candidates running for election is March 18. Last year, the same situation occurred, and a display board was created at DCC for candidates' articles/photos instead of using the Monroe Doctrine; this could be done again this year due to the MD's deadline falling in the middle of the application period. An alternative would be setting an earlier application deadline of March 18 to coincide with the MD's deadline.
- A motion was made by Ms. Velazquez and seconded by Ms. Thompson to approve April 15 as the application deadline. Motion approved.
- SEGA will vote on the Election Packet at the next meeting.

Mentors in Violence Program

- Professor Christine Plumeri has invited SEGA to co-sponsor the program by providing \$500 for refreshments.
- A motion was made by Mr. Carey and seconded by Ms. Velazquez to approve \$250 for refreshments. Motion approved.

- A motion was made by Ms. Ginevra and seconded by Mr. Carey that an ad-hoc committee be formed, comprised of Mr. Cherry, Ms. Ginevra and Ms. Velazquez, to compile the awards application information. Motion approved.
