Resolution to approve the charter of the Latter Day Saints Association

Whereas, the Brighton Campus Student Government Association is charged with the chartering of new clubs and organizations, be it **Resolved**, that the Brighton Campus Student Government Association approve the charter of the Latter Day Saints Association.

NEW BUSINESS Resolutions

Resolution to approve Pratima (Tima) Marathe as Director of Student Services

Whereas section 4E of the Brighton Campus Student Government Association Constitution states the President shall appoint, with Senate approval, all members of the Presidential Cabinet, be it

Resolved that the Brighton Campus Student Government Association Senate Approve Pratima (Tima) Marathe as Director of Student Services in the Presidential Cabinet for the remainder of the 2008-2009 academic year.

Resolution to approve the new draft Constitution

Whereas Article VII of the Brighton Campus Student Government Association Constitution allows any Brighton Student to propose an amendment to said Constitution, and

Whereas such an amendment has been proposed in the form of a new draft Constitution to replace the current version, and

Whereas said proposed amendment must be deemed in order and purposeful in order to be presented in the form of a referendum to the student body, be it

Resolved that the Senate finds the new Constitution, attached, in order and purposeful and further, be it

Resolved that the new Constitution will be presented to the student body in the form of a referendum in the upcoming general Student Government Elections, to wit, the Elections scheduled to be held on May 5 & 6, 2009 and further, be it

Resolved that the current Constitution will remain in force until noon on Commencement Day 2009, to wit, May 28, 2009 and further, be it

Resolved that should the new Constitution be ratified, it shall take effect at noon on Commencement Day 2009, to wit, May 28, 2009 and the current Constitution shall at that time cease to have any effect and further, be it

Resolved that should the new Constitution fail to be ratified, the current Constitution will remain in force and further, be it **Resolved** that ratification of the new Constitution notwithstanding, the current Constitution's terms shall apply to all outgoing members of the current Student Government until the expiration of their terms and further, be it

Resolved that should the new Constitution be ratified, the new Constitution's terms shall apply to all incoming members of the new Student Government from the start of their terms, which shall start as defined in the new Constitution.
