## About the Verification Process

Your FAFSA application has been selected by the federal government for a process called "**Verification.**" MCC's Financial Aid Office will compare the information that you provided on your FAFSA application with the documentation that we are requesting. Corrections will be made to your FAFSA application if necessary. Verifications need to be completed before any federal financial aid can be processed. **This includes Federal Direct Student Loans.**

## Submit the following **REQUIRED DOCUMENTS** to the Financial Aid Office immediately:

1. Copy of SIGNED 2008 FEDERAL INCOME TAX returns for YOU and YOUR PARENTS (if applicable). Submit the **FIRST 2 PAGES ONLY.** (1040, 1040A or 1040EZ)
2. **All sections of this form must be completed including student and parent signatures.** If any questions are left blank on this form, it is considered incomplete and will delay the verification process.

1. Yourself and your parents.
2. Your parent's other children, if they will provide more than half of their support from July 1, 2009 – June 30, 2010.
3. Any others who now live with your parents, if your parents provide more than half of their support and will continue to provide more than half of their support from July 1, 2009 – June 30, 2010.
