## About the Verification Process

Your FAFSA application has been selected by the federal government for a process called "**Verification.**" MCC's Financial Aid Office will compare the information that you provided on your FAFSA application with the documentation that we are requesting. Corrections will be made to your FAFSA application if necessary. Verifications must be done and any corrections made before any federal financial aid can be processed.

To verify your application, **submit the following REQUIRED DOCUMENTS to the Financial Aid Office immediately:**

1. A copy of SIGNED 2006 FEDERAL INCOME TAX returns for YOU and your PARENTS. Submit the FIRST 2 PAGES ONLY.
2. Student and/or parent W-2's if income was earned and no federal tax return was filed. ONLY IF A TAX RETURN WASN'T FILED.
3. Dependent Verification Worksheet, **with all sections completed including student and parent signatures.** If any questions are left blank on this form it is incomplete and will delay the verification process.
