 - ii. You will have up to four minutes for your report out, so feel free to share highlights of your work and don't feel like you need to cover everything.

Summary Work Timeline Institute #6: Institutes Capstone

Pre-work:

- 1) Pre-Institute Reading
 - a) Core team members read <u>"The Policy Leadership Trust for Student Success:</u>
 Overview of the State Policy Framework" from Jobs for the Future (JFF)".
- 2) Scale of Adoption (see attachments for full details and step-by-step instructions)
 - a) Identify 20 members of your larger institution community to complete the Scale of Adoption "Individual Responses".
 - b) Schedule (ASAP) approximately 2-3 hours for your core team to review the "Individual Responses" and to synthesize your "College Team Response". **Due April 26**
 - c) Look for an email to schedule an appointment for your "Facilitated Team Consensus".
- 3) KPI Update Due April 26
 - a) Complete the KPI data update.
- 4) Review of Progress on Implementation and Implications for Sustainability
 - a) Once your "Facilitated Team Consensus" is scheduled, schedule 1-2 hours after that date with your core team to complete the Review of Progress on Implementation and Implications for Sustainability. Discuss the report out with your team.
 - b) Submit as part of pre-work submissions by June 21.
- 5) Review Short Term Action Plan to prepare for team work at the Institute

During the Institute:

- a) Work through the short-term action plan, including
 - Institutional Policies to support Guided Pathways Policy Self-assessment for Governing Boards
 - b. Work Planning Fall 2019 through Fall 2020.
- b) Finalize plans for College Team Report-out

After the Institute:

- a) Finalize **short-term action plan** with appropriate college-personnel.
- b) Complete the **final financial report for the project** (more information will be disseminated soon).
