### Summer 2018 Sessions

May 25 - June 30 - No Federal Work-Study Available.

July 1 - FWS begins Summer 2018

Authorized students begin work after completing necessary documentation with HR.

July 12 & 26 - PAYDAY: Supervisors monitor student work hours & performance

August 9 & 23 - PAYDAY: Supervisors monitor student work hours & performance

### Fall 2018 Semester

August 27- Fall 2018 first day FWS

Authorized students begin work after completing necessary documentation with HR.

October 1-FAFSA application begins. Encourage students to apply for FWS through the FAFSA.
