c) APC: Proposed Revision to Faculty Senate Resolution 1.9.4 – Academic Grievance Procedure R. Fisher reviewed the proposal changes. Motion to support the proposed changes. Motion seconded. *Motion passes.*

d) Policy Review:

Animals at the College

A. Colosimo stated the proposed Policy was tabled at the last meeting to address the suggestion to require services animals to be certified. She explained this is not required at the federal level therefore adding language to the Policy would cause issues. There was discussion and additional questions.

Motion to support the proposed Policy with the inclusion of the edits. Motion seconded. No further discussion. *Motion passes.*

Policy on Relationships of Power Between College Employees and Students formerly known as the Policy on Consensual Relationships

A. Colosimo presented the proposed Policy as revised. She summarizing the changes, feedback form SLCC and her meeting with M. Fingar and K. Lowe.

There were questions clarifying the proposed Policy and discussion on the following feedback:

- Change to title and policy statement to include "Romantic or Sexual" Relationships
- Focus on a Policy between students and employees
- The policy loses its effectiveness when it also includes employees much cleaner and more precise document if only addressing student relationships

After some discussion, A. Colosimo pointed out there were three options to move forward:

- 1. Make a motion to write a memo supporting idea to pulled out the Employees and put into a more appropriate policy such as the Employee Code of Conduct
- 2. Table the Policy and develop more specific language
- 3. Recommendation to create a separate policy rather than included in the Employee Code of Conduct

She also pointed out the Board of Trustees will be voting to on this proposed Policy at its April 9 meeting, however she can address any concerns in her statement to the BOT.

Motion to separate into two separate Policy (Student vs. Employee and Employee vs Employee). Motion seconded. There was discussion and additional feedback provided. Question was called. *Motion rescinded.*

Motion to support the changes as outlined in the edited version including the following feedback:

- Suggestion to change Title
- Separate Employees and Student
- Included Rationale in memo

Motion seconded. No further discussion. Motion passes.

Procurement Policy and Procedure

A. Colosimo presented the proposed Policy and Procedure. There was discussion and questions clarifying the Policy.

Motion to support the proposed Policy with inclusion the suggested edits and questions. Motion seconded. No further discussion. *Motion passes.*

Surplus Policy and Procedure

A. Colosimo presented the proposed Policy and Procedure. She explained the policy was a result of the Damon City Campus move. In the future, there will be an electronic catalog listing surplus property which is available to the College community. There was discussion and questions clarifying the Policy.

Motion to support the proposed Policy with the inclusion of the suggested edits. Motion seconded. No further discussion. *Motion passes.*

3. Future Action Items:

a) Shared Leadership Coordinating Council Bylaws (SLCC)

A. Colosimo stated there will be additional edits and a revised version will be posted to the FS Blackboard for review.

4. Old Business

There was no old business discussed.

5. New Business

a) Building Services and Recycling Committee Update - Blaine Grindle

- B. Grindle gave an update on Building Services. He acknowledged there are issues and provided the following information:
- Currently have open 16-18 positions: the night shift has 11 open positions (1 staff member on medical leave) and the day shift has 4 open positions
- Dealing with complaints daily on what is not getting done
- Building 5 is being cleaned during the day
- He explained two staff members were hired for building 8 however, one person quit before they started. He understands the building is suffering but asked for patience until the staff issues can be resolved.
- Staffing issue not a budgetary issue.

He also explained the Recycling Committee is doing an experiment with the black bins for recycling in several buildings.

There were questions and feedback provided.

b) United Way Campaign - Ryan Messenger

R. Messenger gave an updated on the United Way which runs until April 20. The College goal currently a third of its way to the goal \$110,000. He along with C. Sprague would be happy to meet with departments or answer any questions.
