Additional discussion: M. Redlo asked Dr. Wade if there were similar issues at Broome regarding shortened class time. She offered several suggestions including meeting for more days, increasing seat time for individual classes during the semester, finals weeks became an instructional week (meet to give a final or additional instruction). She discovered the academic calendar is not in compliance with SUNY and Middle States.
