Meeting called to order: 3:35 p.m.

1. Guest: Matt Fox-Sustainability Programs and Degrees

M. Fox reviewed the history and scope of the sustainability movement. Sustainability tries to balance people, planet, and profit. He reviewed the academic disciplines that are weaving sustainability issues into their curriculum. He also reviewed a number of bachelor's programs focusing on sustainability. MCC sustainability programs include an A.S. in Sustainability and the Certificate (which is not F.A.C.E. eligible). Courses include: 30 students in the SUS 101 course this semester. A Sustainability Certificate must be applied for at graduation, it is not a designation on other diplomas.

- **b.** C. Abbott announced that the RCSD changed their 2013 spring break to March 31 April 7 and since MCC follows their schedule this may impact the College's 2012-2013 academic calendar. A question was raised about whether other Monroe County schools will also be changing and if not, do we really need to change our calendar? C. Abbott will look into this and report back to the Faculty Senate.
