Resolutions for the September 28, 2010 Brighton Campus Student Government Association Senate Meeting

Resolution to approve adding the Media Committee as a Standing Committee in the Brighton Campus Student Government Association By-Laws by changing By-law 8.3.6

Whereas, under Article III, Section 6Cp of the Brighton Campus Student Government Association Constitution, the Senate may establish committees necessary for the conduct of its business. The Senate may delegate any powers or duties it sees fit to committees of its choosing, but the full Senate must vote on a committee's recommendation before it may go into effect, and

Whereas, the Brighton Campus Student Government Association Senate requires a two-thirds vote to change the By-laws, and

Whereas, the Brighton Campus Student Government Association Senate has a fiduciary responsibility to help students succeed at Monroe Community College, be it

Resolved, that the Brighton Campus Student Government Association approve the changes to By-law 8.3.6.

Resolution to approve amending the Brighton Campus Student Government Association By-Laws by changing By-law 11.3.5.

Whereas, under Article III, Section 6cm of the Brighton Campus Student Government Association Constitution, the Senate may determine the rules of its proceedings and make rules for the SGA as a whole, and

Whereas, the Brighton Campus Student Government Association Senate requires a two-thirds vote to change the By-laws, and

Whereas, the Brighton Campus Student Government Association Senate has a fiduciary responsibility to help students succeed at Monroe Community College, be it
