Action Requested: We the student governing body of Monroe Community College strongly suggest that Monroe Community College adopt a college wide women's week for students to acknowledge that all humans are born equal regardless of gender.

Whereas: The student government association reaffirms our obligation of inclusivity and gender equality to promote women's rights in an effort to enhance a more aware and inclusive student body and;

Whereas: The student government association would like to emphasize the obligation that the institution of MCC has to promote and protect ALL human rights and fundamental freedoms and;

Whereas: The student government association would like to implement the need for a zero-tolerance policy for gender discrimination at MCC and;

Whereas: One in five women on U.S. college campuses have been sexually assaulted and as of August 2014, 74 colleges in the United States had unresolved Title IX sexual violence investigations and;

Whereas: Women around the world aged 15-44 are more at risk from rape and domestic violence than from cancer, car accidents, war and malaria and;

Whereas: Only 30 percent of the world's researchers are women in fields dominated by men and;

Whereas: Women with full-time jobs currently earn only about 77 percent of their male counterparts' earnings and;

Whereas: 62 million girls are denied an education all over the world; therefore, be it

Resolved: That the student governing body of mcc adopts the following resolution for it to be implemented in the spring semester; be it further

Resolved: that the students of MCC take a pledge in an effort to be proactive against gender discrimination; and finally, be it

Resolved that copies of this resolution be distributed to the following shared governance bodies at mcc: the board of directors, the board of trustees, faculty senate etc .
