Whereas the Christians United for Israel has met the minimum requirements necessary to be considered for a club charter and

Whereas the Monroe Community College Student Government Association Senate approved the charter of the Christians United for Israel club on Tuesday, October 14th . and

Whereas under section 4. A. of the Monroe Community College Student Government Association By-Laws, the executive power of the SGA shall be vested in a President, who: Shall, within 48 hours, take action on all acts of the senate.

Whereas President Mark White vetoed the approval of the charter of the Christians United for Israel club and

Whereas under section 6.C.9 By a two-thirds vote of the Senate present and voting, the Senate may override a Presidential veto and

Whereas a member of the Christians United for Israel club must be in attendance at the open senate meeting on Tuesday, October 28th,

Be It Resolved that the Monroe Community College Student Government Association Senate approves the Christians United for Israel charter.

WHEREAS, under Article III, Section 4E of the Brighton Campus Student Government Association Constitution, the President shall appoint by and with the advice and consent of the Senate, all members of the Presidential Cabinet.

WHEREAS, the Brighton Campus Student Government Association President Mark White has appointed John Fisher to sit on the Presidential Cabinet,
