### **Resolution to approve Committee Members to the Rules Committee**

### **Resolution to approve Jenny Blum as the Director of Multicultural Affairs**

*Whereas*, Article III, Section 4E of the Brighton Campus Student Government Association Constitution states that the President shall appoint, with the oversight and consent of the Student Senate, all members of the Presidential Cabinet, be it

*Resolved*, that the Brighton Campus Student Government Association Senate approves, using due process, Jenny Blum as the Director of Multicultural Affairs for the remainder of the 2009-2010 academic year.

### **Standing Rule on Programming Budget Allocations**

*Whereas*, under Article III, Section 6C(p) of the Brighton Campus Student Government Association Constitution, the Senate “may delegate any powers or duties it sees fit to committees of its choosing, but the full Senate must vote on a committee’s recommendation before it may go into effect,” and

*Whereas*, it would ease and expedite the planning and execution of events if the Events Committee had the authority to allocate the funds contained in the SGA Programming Budget, therefore be it

*Resolved*, that the Senate hereby delegates the power to allocate the funds contained in the SGA Programming Budget to the Events Committee for the remainder of the 2009-2010 academic year, or until this standing rule is revoked by the Senate, whichever comes first, and further be it

*Resolved*, that the Senate must still approve any allocation made by the Events Committee prior to the execution of said allocation, as required by the Constitution.
