## II. SPEAK TO THE SENATE

Dr. Otero, Executive Dean, Damon City Campus, and Bob Cunningham, Director of Academic Services Planning & Learning Environments, explained that they are looking for students thoughts regarding what constitutes a new campus. The new downtown campus is envisioned as a destination; a place that draws students, faculty, staff and community members to its doors; a place of engagement and collaboration. It should be a purposeful and inviting place. With that in mind, he asked the Senators what their thoughts are concerning the essential design elements and the essential academic and student services programming elements that would make the vision a reality. He mentioned that the location will be somewhere within the inner-loop.

Some of the thoughts and concerns shared were:

- ✓ Location should be conducive to the many students who commute between the campuses; keep the location of the bus route in mind.
- ✓ Ample parking; parking is a major issue
- ✓ Open air/green space; possibly utilize the roof area
- ✓ Tabletop areas in lecture halls need to be larger
- ✓ Area where students want to spend time
- ✓ Larger common area for eating along with smaller areas where students can go for study groups, quiet areas, technology areas
- ✓ Residential housing for students
- ✓ Sustainable building
- ✓ Keep classroom without windows at a minimum
- ✓ More digital signage; allowing artists in the community to showcase their art work
- ✓ More smart rooms
- ✓ WMCC broadcast on campus

- ✓ Areas for faith based groups
- ✓ More computers not just in the library but also around the building
- ✓ More commercial/independent food services
- ✓ Utilize area health providers
- ✓ More print stations
- ✓ Better acoustically good performance area
- ✓ Shuttle service
- ✓ Wider hallways

# a. Resolution to endorse the Community College Financial Bill of Rights

**Resolved,** that the Brighton Campus Student Government Association of Monroe Community College hereby endorses in full the provisions of "The Community College Financial Bill of Rights," as passed by the Student Assembly of the State University of New York, and further, be it

**Resolved,** that the Brighton Campus Student Government Association of Monroe Community College requests that Melody Mercedes, President of the Student Assembly of the State University of New York and SUNY Trustee, along with Will Madera, Director of Community College Affairs for the Student Assembly of the State University of New York, or their designee(s), make all due effort to see the provisions of "The Community College Financial Bill of Rights," as passed by the Student Assembly of the State University of New York, put into effect as statewide policy to benefit and assist the students of Community Colleges across the state, including the students of Monroe Community College, both now and in the future.

**Speaker Carey** called for a motion to endorse the Community College Financial Bill of Rights.

**Senator Cohen** so motioned, seconded by Deputy Speaker Ruhindi.

#### **Discussion:**

**Senator Cohen** explained that in April the SUNY Student Assembly representatives voted to approve the bill called the Community College Financial Bill of Rights. All 30 Community Colleges across the state have to deal with some form of a Faculty Student Association. MCC's is the MCC Association. Not

every Community College has as good a relationship with their FSA as MCC does. Many of the Student Governments have continual problems with their FSAs and the Community College Financial Bill of Rights was developed to try to alleviate the issues. President Melody Mercedes of the SUNY Student Assembly, who also sits on the SUNY Board of Trustees, and Director of Community College Affairs Will Madera, who sits on her Cabinet, wish for Community College Student Governments across the state to pass the same bill or a bill endorsing the original resolution passed at spring conference so they can bring up these endorsements when they go to the meeting of the New York Community College Association of Presidents at the beginning of October. Senator Cohen requested a roll call vote.

### A roll call vote was taken:

Be it resolved, the Monroe Community College Brighton Campus Student Government Association Senate endorses, in full, the provisions of "The Community College Financial Bill of Rights," as passed by the Student Assembly of the State University of New York and requests that Melody Mercedes, President of the Student Assembly of the State University of New York and SUNY Trustee, along with Will Madera, Director of Community College Affairs for the Student Assembly of the State University of New York, or their designee(s), attend the next meeting of the New York Community College Association of Presidents (NYCCAP) to communicate said endorsement to that group, and also requests that Melody Mercedes, President of the Student Assembly of the State University of New York and SUNY Trustee, along with Will Madera, Director of Community College Affairs for the Student Assembly of the State University of New York, or their designee(s), make all due effort to see the provisions of "The Community College Financial Bill of Rights," as passed by the Student Assembly of the State University of New York, put into effect as statewide policy to benefit and assist the students of Community Colleges across the state, including the students of Monroe Community College, both now and in the future.
