Meeting called to order: 3:38 p.m.

1. Guest Speaker: Ann Pennella (CCTE):

In January 2011, a FIPSE innovation grant was awarded to MCC to establish the Community Center for Teaching Excellence (CCTE). The Community Center for Teaching Excellence is designed to create a K-20 pipeline for student success. FIPSE innovation Grant funding started in January 2011; a Facilitation Committee was formed including partners named in the grant: two K-12 districts (Rochester City and Rush-Henrietta), and three 4-year colleges (SUNY Brockport, Geneseo, and St. John Fisher). The Facilitation Committee began forming a vision, mission and goals. In April –June 2011, there was a staff search and selection. In in July – September 2011, the new Director conducted an initial literature review and worked to solidify relationships with all partners. In October-December 2011, the core documents on Vision, Mission, and Goals were finalized, a review of baseline student data occurred, and the group developed a glossary of terms common across K-20. The Faculty Fellows Program for K-20 Educators launched in March 2012 with MCC faculty and teachers from Rush-Henrietta and RCSD. Currently

(Fall 2012), there are twenty-two Fellows implementing instructional changes and doing action research to assess the impact on student learning. Applications to participate in the Fellows Program beginning in Spring 2013 (a two semester program Spring-Fall) will be available next week. The goal is high impact teaching strategies to better prepare students for college, shorten time to completion, improve post-secondary performance and satisfy a need for skilled individuals for the workforce.

There are two more discussions planned for the Spring semester. She asked that the Senators please encourage their colleagues and constituents to attend.

SCAA (M. Fine and C. Abbott)

- M. Fine reported that SCAA has joined forces with the Administration's search committee for Assistant Vice President for Enrollment Management. Tentatively, interviews will begin first two weeks in December with Open Forums at the end of January and/or early of February.

- C. Abbott reported, as chair of SCAA during the review of the Advising Services Center proposal, that the Committee's report was submitted to S. Salvador on October 10th. The Committee supports the proposal in terms of creating a new Advising Services Center by merging Advising and Graduation Certification Office. However, several concerns were addressed in the report regarding the details of the proposal such as where the support staff would be placed.
