**Subject: Electric car ports added to parking lots**

Whereas the Student Government Association feels that the rate of students and faculty driving electric vehicles is progressively increasing; and

Whereas this implementation would be according to the change in times and advances in technology that are occurring in the 2013-2014 year; and

Whereas this initiative would be in accordance to MCC's master plan and goal of becoming and encouraging a more sustainable campus; and

Whereas students and faculty driving these electric cars could use the time in class to charge their vehicle that otherwise would not be charged; and

Whereas this will be a 21<sup>st</sup> century effort for sustainability not yet done by a majority of community college campuses thus keeping MCC as a precedent setting institution; and

Whereas the Student Government realizes the scarce ownership of electric cars in both the student and faculty population; therefore, be it

Resolved that the Student Government Association of Monroe Community College in an effort to accommodate electric-vehicle driving students and staff requests and advocates for electric car charging ports to be added to the parking lot infrastructure of MCC Brighton Campus; and, let it further be

Resolved that the SGA would like to remain involved and helpful in the process, if any, for implementation but supports leaving the number of ports and the locations of said ports at the discretion of the powers vested to make such decisions; and, be it finally
