# Resolution to approve the funding of GU's trip to DC.

Whereas under article II, section 6.C.7 of the MCC SGA constitution, the MCC student government Association Finance Committee has approved \$6,000 from the senate contingency account for the Global Union to go on a trip to DC open to the whole campus to visit historic sites to our country and such locations as American university and the Smithsonian in the month of April.

Whereas a majority vote of the senate is required to approve such funding, the MCC Student Government Association Finance Committee asks the senate to approve the funding of \$6,000 from the senate contingency account to lower the cost per students to go to said place.

Whereas the GU Association has been informed that a representative from the club has to be in the audience at the senate meeting on Tuesday November 4<sup>th</sup>

# Whereas under section 4.3.1 of the Monroe Community College Student Government Association By-Laws, students desiring to form a club must meet some basic minimum requirements to be chartered.

Whereas the Christians United for Israel has met the minimum requirements necessary to be considered for a club charter and

Whereas the Monroe Community College Student Government Association Senate approved the charter of the Christians United for Israel club on Tuesday, November  $4^{th}$  . and

Whereas under section 4. A. of the Monroe Community College Student Government Association By-Laws, the executive power of the SGA shall be vested in a President, who: Shall, within 48 hours, take action on all acts of the senate.

Whereas President Mark White vetoed the approval of the charter of the Christians United for Israel club and

Whereas under section 6.C.9 By a two-thirds vote of the Senate present and voting, the Senate may override a Presidential veto and

Whereas a member of the Christians United for Israel club must be in attendance at the open senate meeting on Tuesday, November 4th
