The FSA ID students and parents Frequently **Asked Questions**



What is the new FSA ID for Federal Student Aid?

The new FSA ID will replace the Federal Student Aid PIN to access the federal student aid information and sign including:

- 1. the FAFSA,
- 2. the National Student Loan Data System,
- StudentLoans.gov,
- 4. StudentAid.gov, and the
- 5. TEACH Grant website.

The FSA ID which will consist of a <u>user-selected</u> username and password.



How will the FSA ID be different from the PIN?

The ID will allow students and parents to access federal student aid websites without having to enter a name, Social Security number or date of birth. The switch is meant to better comply with online security standards.



What happens for a new user?

- New users will be directed to the registration page to create an FSA ID (Username and Password).
- Registration requests the same required information as PIN.

What happens if a user has a PIN already?

- During account creation, the user will be asked for their PIN.
- As long as the PIN information matches their other information, the account will be linked to the FSA ID account.
- Individual student and parents will transition to FSA IDs as they come back to interact with FSA systems.

What if I've already completed and signed my FAFSA with my old PIN?

You will be able access your 2015-16 FAFSA with your new login info even if you submitted your FAFSA using your soon-to-be-obsolete FSA PIN.



Do parents of dependent students need their own FSA ID and Password?

Yes, parents of dependent students are required to create their own FSA ID. Much like the old FSA PIN, parents will use their own FSA ID to authenticate their identity and sign their student's FAFSA.



Will students and borrowers be able to access their previous FAFSA and loan information?

Yes. The FSA ID will allow a student or borrower to access all the information that they can today with a PIN.
