Resolution to Approve the Funding of \$500.00 to the American Sign Language Club

Whereas, under Article III Section 6 C.g. of the Brighton Campus Student Government Association Constitution, the Brighton Campus Student Government Association Travel and Finance Committee has approved \$500.00 to the American Sign Language Club, and

Whereas, a majority vote of the Senate is required to approve such funding, the Brighton Campus Student Government Association Travel and Finance Committee asks the Senate to approve \$500.00 for the funding of the American Sign Language Club, therefore be it,

Resolved, that the Brighton Campus Student Government Association Senate approves the funding of \$500.00 to the American Sign Language Club.

Resolution for Designee Appointments to the Faculty Senate

Whereas, section 8.1.1 of the Brighton Campus Student Government Association By-Laws states that the Vice President of the Brighton Campus Student Government Association and the Deputy Speaker of the Senate shall serve as the Brighton Campus Student Government Association representatives to the Faculty Senate, and

Whereas, the Vice President and the Deputy Speaker have been nominated and recommended to the Budget Resource Committee by administration of the college, and

Whereas, the Vice President and the Deputy Speaker feel it is necessary to appoint a designee to the Faculty Senate to maintain the student voice within the Faculty Senate, and

Whereas, Article VII of the Brighton Campus Student Government Association Constitution allows the Senate to adopt changes to the By-Laws by a two-thirds vote, be it

Resolved, that the Brighton Campus Student Government Association Senate allows the Vice President and the Deputy Speaker to appoint a designee to the Faculty Senate for the 2010-2011 academic year, and further be it

Resolved, that the Brighton Campus Student Government Association Senate will confirm, by two thirds vote, the designees of the Vice President and the Deputy Speaker to the Faculty Senate for the 2010-2011 academic year at a Public Senate Meeting. These changes are only effective for the 2010-2011 academic year due to anticipated by-law changes.
