Be it resolved that we vote on the funding request submitted by the Engineering leadership council

Whereas the ELC has requested funds in the amount of \$3620.28 for two students to go to a conference in los Angeles to attend a conference held for female engineers to build leadership skills.

Whereas under the bylaws of the SGA Senate Contingency Request terms and conditions, of which they read and agreed upon, in section 1 bullet 2 one requirement they need to comply with in order to receive funding considerations is to attend round table meetings.

Whereas ELC has not met the requirement of attending roundtable, we have agreed to consider half of what they requested which is in the amount of \$1810.14

Be it resolved that we vote on the matter of granting student music association there funding request.

Whereas the Student music association requested the funds of \$3500.00 from the Travel contingency

Whereas these funds will be used in conjunction with the added amount of \$3729.00 attendees are paying out of pocket and the \$250.00 being requested from the fundraising account to equal the total cost of the desired trip of which cost \$7479.00

Whereas there goal with said funds is to go to Carnegie Hall in NYC with seven attendees in order to perform with other choir members from around the country to perform a large choral work under a nationally known director accompanied by a professional orchestra.

Whereas under the bylaws of the SGA Senate Contingency Request terms and conditions, of which they read and agreed upon, in section 1 bullet 2 one requirement they need to comply with in order to receive funding considerations is to attend round table meetings.

Whereas they have not been in compliance with the requirement of attending the roundtable meetings we agreed to consider half of what they requested in the amount of \$1750.00

Resolution to approve the funding of 2,585 to the Campus Ambassadors

Whereas, under Article II, Section 6.C.7. of the MCC student government association constitution, the MCC Student Government Association Finance Committee has approved 2,585 from the senate contingency fund to the Campus Ambassadors for and even known as the Campus Ambassadors Fall Retreat, and

Whereas, the amount of 2,585 would go towards paying for lodging, rental equipment, and retreat supplies on the trip, and reduce the amount per student.

Whereas, a majority vote of the senate is required to approve such funding, the MCC Student Government Association Finance Committee asks the Senate to approve the funding of 2,585 from the Senate contingency fund to sponsor the Campus Ambassadors Fall Retreat, and

Whereas, the travel club has been informed that a representative from the club needs to be in attendance at the public Senate Meeting on Tuesday, October 7th, therefore be it

Resolved that the Senate consents to funding of 2,585 to the Campus Ambassadors to sponsor the Campus Ambassadors Fall Retreat.
