



Student Right-to-Know Act

Graduation/Completion Rate Report

In accordance with the Higher Education Act of 1965, as amended, Monroe Community College provided the following information on the graduation/completion rates for three cohorts of full-time, first-time, degree seeking students who enrolled during the fall semester and student athletes that received athletic financial aid. While reviewing this information, please keep the following in mind:

- Students who already attended another postsecondary institution, or who began their studies on part-time bases, are not tracked for graduation or transfer out rate.
- Graduation rates are based on degree or certificate completed within 150% of the normal time-to-completion (three years for a two-year degree)
- Transfers out rates are based on students from the cohort who transferred to another school within 150% of the normal time-to-completion (three years for a two-year degree) without completing a degree or certificate.
- The incoming cohort may be adjusted for students who left school to serve in the armed forces or on official church missions or with foreign aid service of the federal government, or students who died or were totally and permanently disabled.
