Information Items

- Chair Williams began the meeting by welcoming Student Trustee Mia Le to her first official Board meeting.
- A presentation was given by Andrew Kelly, Manager, and Jonathan Miller, Partner, from The Bonadio Group regarding audit planning and scope.
- CFO and VP Administrative Services Greg Hinton gave the financial report. Mr. Hinton reported on key financial highlights related to revenue, expenses, and enrollment for YTD June 30, 2022 as follows:
 - o Enrollment is down 9% from the prior year and has achieved 99% of budget. There was a decrease in full time enrollment of 9%.
 - Revenue is down 10.1% from the prior year primarily due to the decrease in enrollment, student fees and state aid. Federal Aid (HEERF) of \$3M partially offset the decrease.
 - Expenses are down \$1.1M or 1.3% YOY and has achieved 78% of budget. This is
 primarily related to a decrease in salaries and benefits, the continuous review of
 vacancies and the strong college community support of expense management.
- The Board entered into Executive Session at 4:27 pm and adjourned at 5:03 pm.
- The meeting reconvened at 5:08 pm.
- The business portion of the meeting ended at 5:28 pm.
- President Burt-Nanna thanked the Board for its confidence in her leadership and recognition of her investment in the overall success of the college and community. Dr. Burt-Nanna acknowledged the current state of affairs in Rochester and nationally. MCC commits to making education affordable and accessible to all zip codes as a strategy to counterbalance the crime and poverty and educate citizens to make informed choices. MCC also prioritizes employee and student health and safety. The President thanked the County Executive and Monroe County Legislature to continue to make it possible for MCC to carry out its mission. The joint committees of the Monroe County Legislature unanimously endorsed approval of our budget ask of \$750K and full year tuition increase of \$50 which the MCC Student Government Association endorsed. The President also highlighted MCC is designated to receive an additional \$4.1M in one-time funding from NYS to promote workforce development and bolster student enrollment and retention. Receipt of those funds are subject to SUNY approval of a Plan for its use. MCC continues to monitor the latest developments on COVID-19 and Monkey Pox and in consultation with SUNY and Monroe County health officials. There is currently no change in guidance.

- Dr. Burt-Nanna and William Dixon reviewed the 2022-2027 Strategic Plan Key Performance Indicators (KPIs) and the Board endorsed their adoption.
- Divisional highlights were shared with the Board and each cabinet member highlighted one to two items from their report.
- VP Hinton discussed the College's voluntary participation in a review of its facilities for ADA-compliance.
- Mark Pastorella, Associate Vice President, Development, MCC Foundation gave the Foundation Report. The 38th Annual Scholarship Open raised over \$100,000 in support of students at MCC. The annual campaign raised \$534,377 and is a key support for Foundation operations and areas of greatest need. The Foundation has raised \$8,890,465 in total support for the academic year. Major Gifts, Special Events and the Annual Fund make up the total support provided to the Foundation. New Foundation Directors include Brian Capitummino, Partner, Woods Oviatt Gilman LLP; Loren Flaum, Chief Financial Officer, Flaum Management Co., Inc.; Doug Parker, Senior Vice President/Financial Advisor, Sage Rutty & Co., Inc.; Patricia Redding, President, Saunders Management, Inc. The next event of the year is the 31st Annual Salute to Excellence which will be held on November 10th. This year's salute will pay tribute to Monroe Community College's 60th Anniversary and will celebrate MCC Alumni Hall of Fame Inductions. The Salute to Excellence Award will be presented to the ESL Charitable Foundation and the Salute to Volunteerism Award will celebrate the many contributions of Dr. Alice Holloway Young.
- Student Trustee Mia Le has been working with the Educational Opportunity Program (EOP) Pre-freshman Summer Bridge program which is a four week on-campus program which provides support services and introduces students to college learning. In August, Trustee Le will be attending the ACCT Governance Leadership Institute (GLI) for New Trustees in Washington DC. Trustee Le has also been working with the Student Government Association (SGA) on training and recruitment. As a Senior Resident Assistant of the Housing and Residence Life Team, Trustee Le will be participating in an intensive two-week training session starting August 11th.
- Student Government Association (SGA) President Paula Barlow noted that this year's Office of Student Life and Leadership theme is "Imagine, Believe, Achieve." Their goal is to align their service with MCC's new strategic plan. SGA has been working on training and recruitment this summer. They are in the planning process for the 9/11 ceremony. A few members of SGA attended the Turbo Vote presentation which was developed by Democracy Works with is a nonprofit organization that works to simplify the voting process. The Office of Student Life and Leadership received a grant to offer this service to students. Turbo Vote is an online service to help students vote.
- President Burt-Nanna provided a report for administration. Dr. Burt-Nanna commended the Faculty Senate, Student Government and Support Staff Planning Council for the countless

ways they have demonstrated their willingness to work together for the greater good of the College.

- President Burt-Nanna also highlighted the willingness of Tom Pollizi, CSEA President, and Bethany Gizzi, FA President, for fostering and restoring positive relations with College administration. Dr. Burt-Nanna commended both as effective and devoted leaders of their members. Dr. Burt-Nanna also expressed appreciation to the Faculty Association Union Negotiation teams led by Kristin Lowe, Executive Director, Human Resources and Organizational Development, and Bethany Gizzi, FA President, and to each member of their teams. A milestone 5-year agreement was reached with the Faculty Association in just three months of negotiations.
- FA President Bethany Gizzi expressed appreciation for the support of the Board and President during the negotiation process and for the agreement that was reached. Ms. Gizzi also thanked the President for her intentional efforts to create an environment where true partnership has been reached. One of the primary goals of the negotiations was to address inequities in prior salary models and this contract makes significant progress toward those goals. Ms. Gizzi acknowledged the FA and management teams for their efforts which was a much more cooperative and positive process overall. The work done over the past year has helped to rebuild a relationship of trust and strengthen the labor management relations. They look forward to continued collaboration with management to service the students and college community. Ms. Gizzi also highlighted the FA Follow Your Dream Scholarship Recipients: Jennifer Ames, Psychology; Jeffrey Herberger, Geology; Samuel Roberts, Computer Science; and Ashraf Saleh, Liberal Arts and Sciences. Retired FA Member Don Beech presented the scholarships.
- The meeting adjourned at 6:32 pm.
