Kress Updates High Falls Business Groups

MCC President Anne M. Kress updated members of the High Falls Business Association and High Falls Business Improvement District on the new downtown campus' progress at their Jan. 21 meeting.

Kress overviewed the project's timeline, progress to date and potential campus features, but above all emphasized the college's interest in and commitment to being a positive, contributing member of the High Falls neighborhood.

Noting his multiple perspectives—chief executive officer of project developer LaBella Associates, which is located in High Falls, and a member of the MCC Foundation board of directors—Sergio Esteban said, "We are so happy to have MCC as a neighbor. LaBella is creating a campus that we are not only proud of as engineers and architects, but also pleased to have in our neighborhood."

High Falls business representatives in attendance expressed interest in and support for the new campus. Questions and comments touched on class patterns, parking and transportation, safety plans, potential for growth, and opportunities for synergies between the campus and the neighborhood.

Kress' presentation complemented Monroe County Executive Maggie Brooks' remarks to about 450 attendees at the Rochester Downtown Development Corporation and Rochester Rotary Club luncheon on Dec. 10. County Executive Brooks highlighted MCC's campus as an example of the positive changes happening in the city of Rochester.

First Phase of Interior Work Underway



Work on the building's interior is underway to prepare Monroe Community College's new downtown campus for main construction.

The first phase of the interior work, which began in December, includes:

- Separating MCC's future campus from the adjoining buildings owned by Eastman Kodak Co. and Carestream Health Inc., including the separation of utilities and connecting bridges.
- Performing selective demolition, such as ceiling removal.
- Abating asbestos.

Ceilings, carpet, furniture, light fixtures, exit signs and some utility conduits (left) have been removed to prepare the area for asbestos abatement.

Under the oversight of the project's construction manager DiMarco Constructors, several local contractors are doing the work: Environmental Construction Group, Crosby-Brownlie, Navalis Construction Services, Eastcoast Electric, and Steve General Contractor.

The project is moving forward in partnership with the Monroe County Department of Environmental Services and is on schedule for a fall 2017 opening.
